

Minutes of the Lewis County Development Corporation Regular Board Meeting | March 7, 2024 Lewis County JCC Education Center | Lowville, NY

- I. Call to Order
 - a. Chairman Tim Petersen called the meeting to order at 10:49AM.
- II. Privilege of the Floor
 - a. Kruger
 - i. Gilles Cole and Chuck Loon joined the meeting via Zoom to provide an update on the project. Kruger plans to submit an RFP for credits through NYSERDA in June for the project, and the intent to close on the option for additional land needed for the expansion will happen within the next 30-60 days. LCDC Board members urged Kruger to make the building aesthetically pleasing given the future development of the site, as well as provide public access to provide a better view of the falls. The LCDC board requests that staff request design oversight from Kruger.
